The **European Week of Regions and Cities** event was created in 2003 and in the past years has become an EU-wide networking platform for experts in regional and local development. Dealing with topics such as social inclusion, cross-border cooperation, public-private partnerships and regional innovation, the event serves to exchange practices and form new partnerships. This year, it welcomed more than 9.000 visitors in more than 300 workshops, exhibitions, participatory labs and presentations.

Together with presenters from Mediterranean regions, we offered tastings of local and authentic food products from our cross-border area, and regions of the <u>Interreg IPA CBC Croatia-Serbia Programme</u> as well. Our idea was to present the variety of cultural, geographic and gastronomic practices of our regions. The tasting session was held at the Agora Village and it attracted several hundred visitors on day two of the EWRC.

About us

Interreg IPA Cross-border Cooperation Programme Croatia - Bosnia and Herzegovina - Montenegro 2014-2020 is part of the European Territorial Cooperation (ETC), better known as Interreg.

The Programme is managed by the Managing Authority and assisted by the Joint Secretariat within the Ministry of Regional Development and EU Funds of the Republic of Croatia. Both the MA and JS are a team of (mostly) young and ambitious experts dedicated to supporting regions in working together across borders.

The Programme covers Croatia, Bosnia and Herzegovina and Montenegro's cross-border area: 12 counties in Croatia, Brčko District and 109 municipalities in Bosnia and Herzegovina and 10 municipalities in Montenegro. It seeks to strengthen the social, economic and territorial development of the area.

The overall budget of the Programme for the 2014-2020 period is 67.241,552,00 EUR. The allocation originates from two funds: the ERDF and IPA II cover more than 57 million EUR while the remaining 10 million EUR is covered with national co-financing.
