

- > enhancing SMEs cross-border business cooperation.



- perform on-site controls of Small Projects.

# **Project activities:**

Beginning and establishment of SPF implementation for final recipients (SMEs)

upgrading and adapting the web platform, creation of complete documentation for SMEs – guidelines for applicants, evaluation manual, application forms, checklists, call for applicants, etc.), Selection Committee (SC) appointment and procurement of equipment;

#### Announcement of calls for SMEs

- planned 3 calls; the first call for project applications for final recipients is expected in April 2024;
- different (lower) thresholds may be applied for each call (depending on interest of SMS, committed and available funds per call);
- micro and small SMEs (2-4 applicants per project);
- the planned duration of Small Projects is 12 months;

# Review and ranking of project applications

 HAMAG-BICRO, Sector for Evaluation and Contracting Projects in cooperation with Project Management Team (PMT) will carry out the selection process and propose a list and Small Project Applications for the signing of the contract and implementation

# Selection of Small Project applications and approval by the Selection Committee (SC)

The role of the Selection Committee - members of SC comprising from the members from all three Participating Countries (two voting members from each participating country, as well as non-voting members/observers from JS, MA and NAs) will carry out:

# Fulfilment of conditions (FoC) and contracting of small projects with SMEs (final recipients)

- HAMAG-BICRO will prepare the contract for each Small Project including certificates of de minimis aid granted within project. Selected SMEs will sign a contract and start with implementation of their Small Projects.
- Planned support for final recipients will be as **de minimis** aid granted under the Interreg VI-A IPA Programme Croatia Bosnia and Herzegovina -Montenegro 2021-2027



# Implementation of small projects

upon contracting after each call, SMEs implement small projects in max. duration of 12 months

# Reporting of SMEs (final recipients) and payment of funds

- SMEs report through the web platform on the activities and expenses every 3 months;
- HAMAG-BICRO will set up the Management Verifications of Small Projects Team (MVSPT) that will review
  the reports, if needed ask for completion and approve the submitted reports;
- After approval of the report payment will be made towards SMEs.

Projects up to EUR 100,000.00 - using Lump sum (draft budget method) will be paid after each of 3 milestones and proven results

Projects up to EUR 170,588.00 - using SCO1 Flat rate will be paid after approved report (on 3-month basis) based on proven results and costs

# Control of small projects

 MVSPT will carry out on-spot checks of small projects as part of management verifications of the costs of small projects on representative sample basic



# Promotion and visibility

- the existing <u>online platform</u> will be upgraded and adapted and will be a comprehensive tool for final recipients containing all project documentation and information, media for partner search, submission of project applications and reporting;
- creation of <u>leaflets</u> and <u>brochure</u> about the SPF project and Small Projects, online <u>publication of good</u> <u>stories;</u>
- awareness raising events (for each call) in all three participating countries;
- creation of <u>short video teasers</u> for each call;
- organization of <u>contract award events</u> after each call;
- organize <u>study visits</u> for representatives of SC and Programme to exchange knowledge, experience and good practice in the field of entrepreneurship of cross-border projects;
- holding <u>3 conferences</u> (initial, middle and final);
- making a <u>video</u> for the final conference with achieved results;
- presentation of the project at other events.
