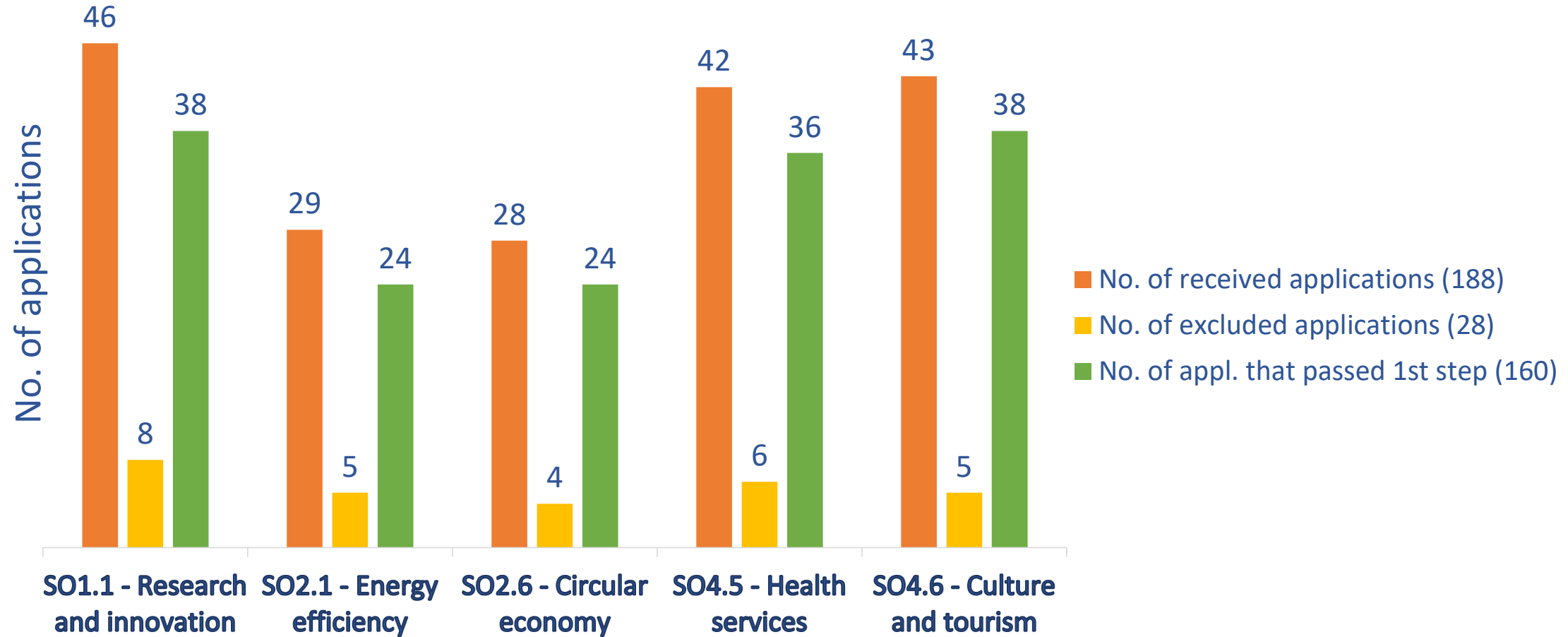

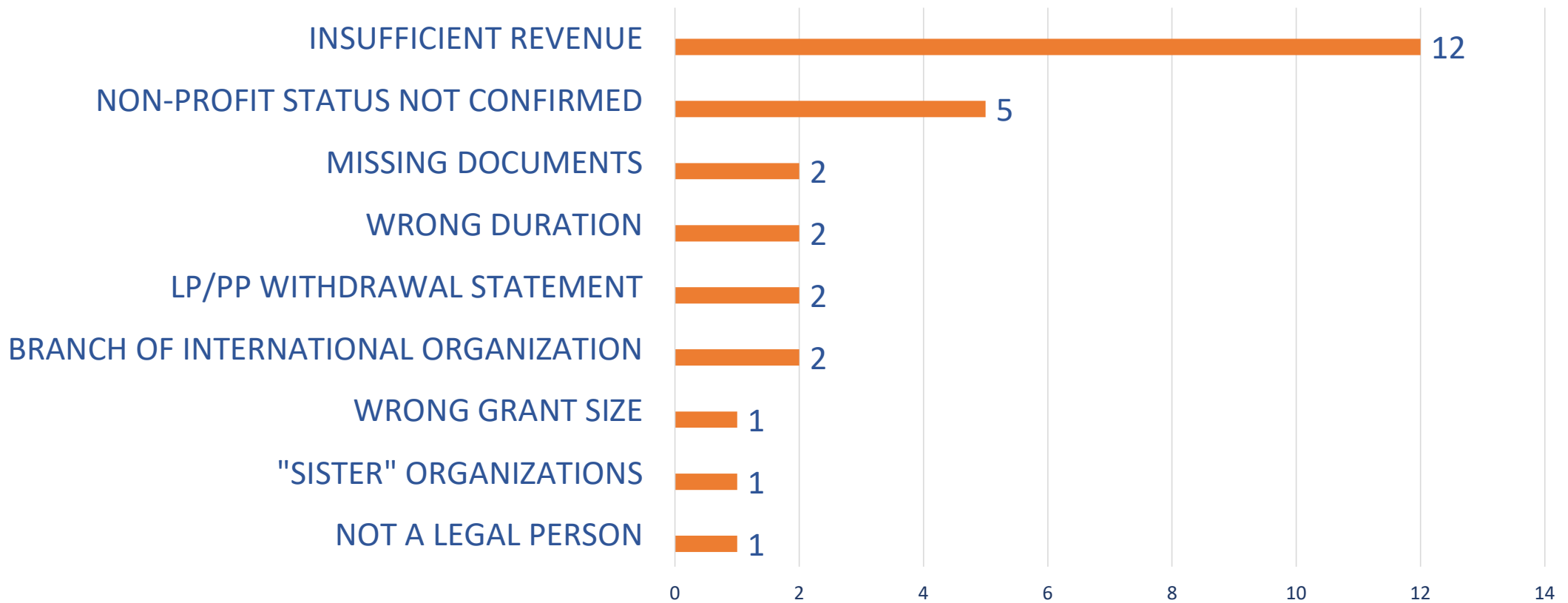

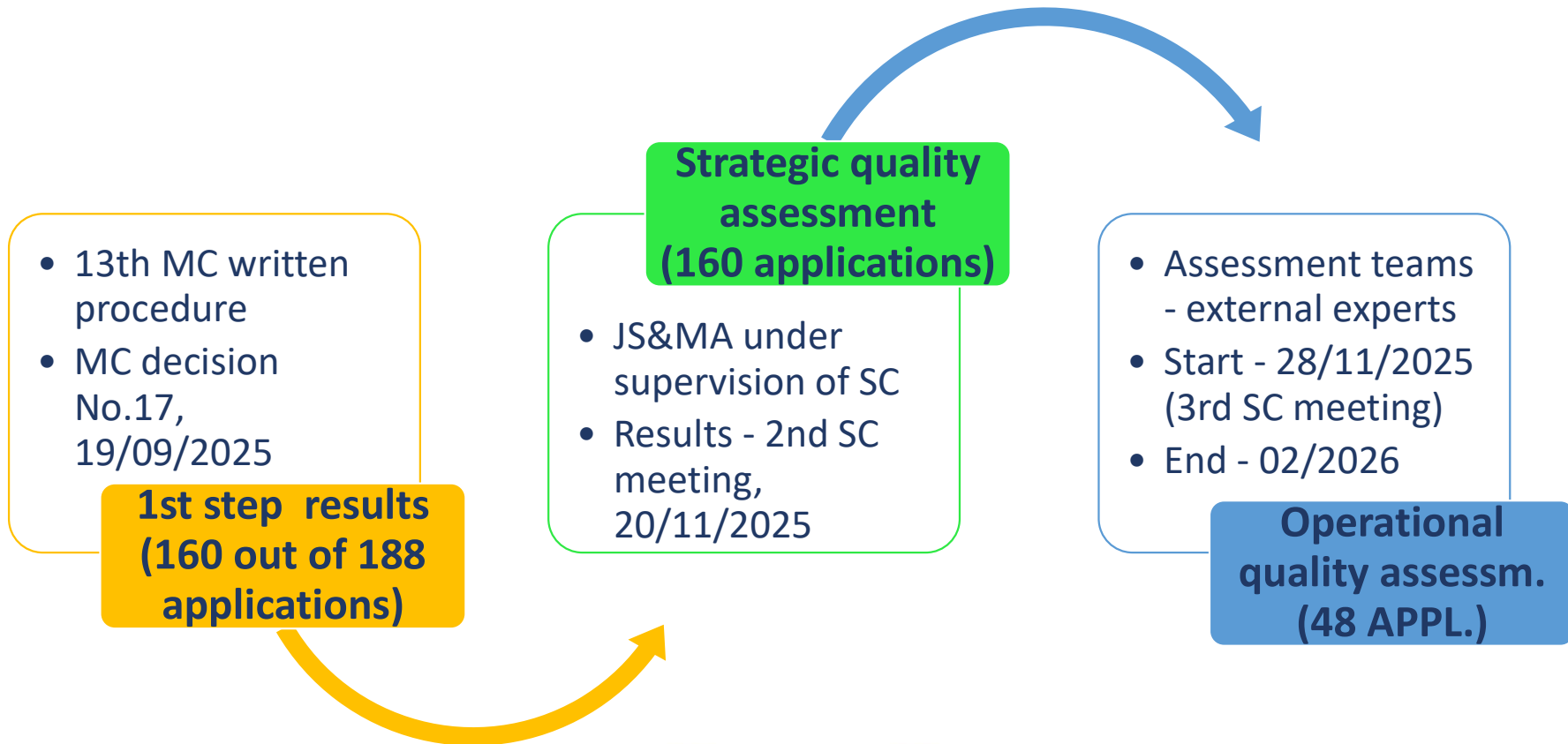


## 2nd Step: Quality Assessment - procedure

ASSESSMENT CRITERIA	MAXIMUM SCORE
STRATEGIC CRITERIA	GO / NO GO
OPERATIONAL CRITERIA	67 (65 assessors + 2 additional SC)

- To be **considered for funding**, both conditions must be fulfilled:
  1. assessed with **GO** for all **Strategic** assessment criteria,
  2. **at least 35** points for **Operational** assessment criteria.
- **NO GO** for Strategic assessment criteria – Application **will not be further assessed**
- **Less than 35 points** for Operational assessment criteria – Application **will be rejected**

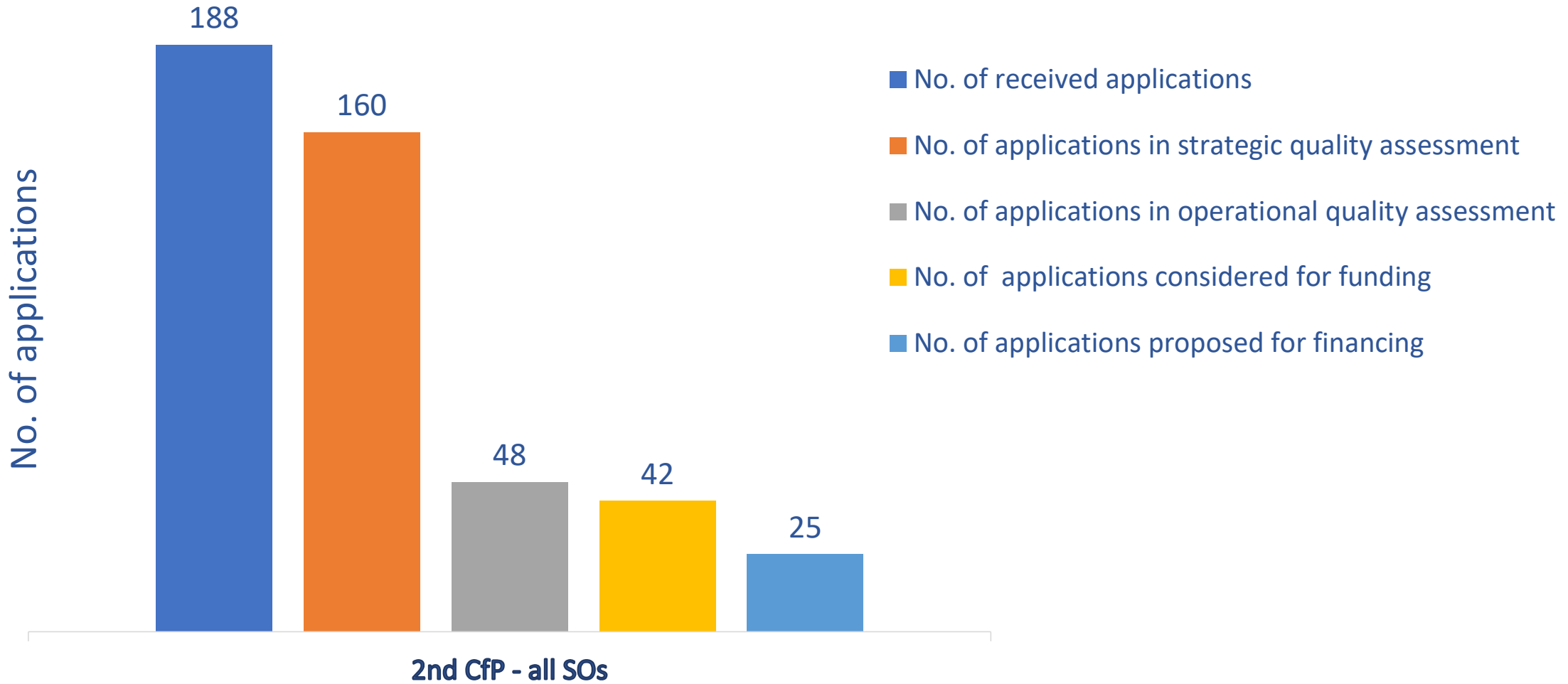

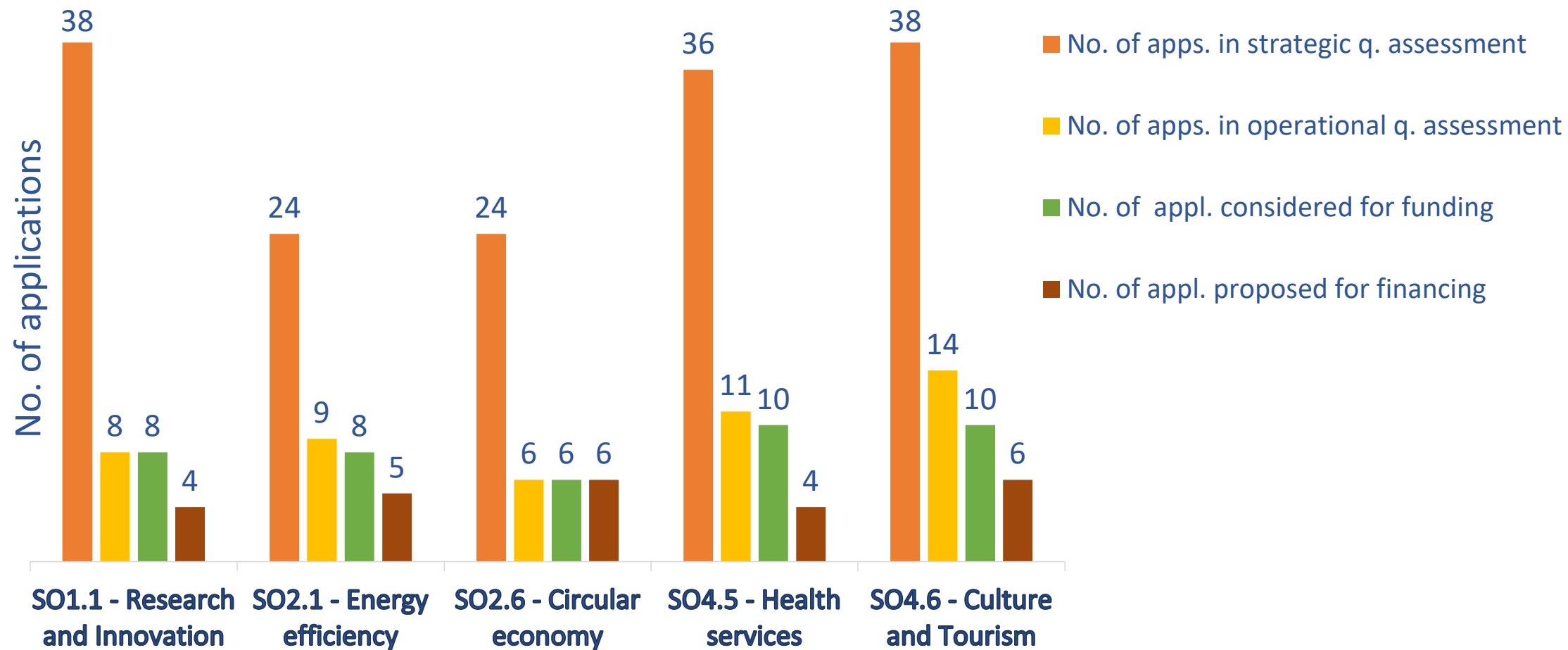

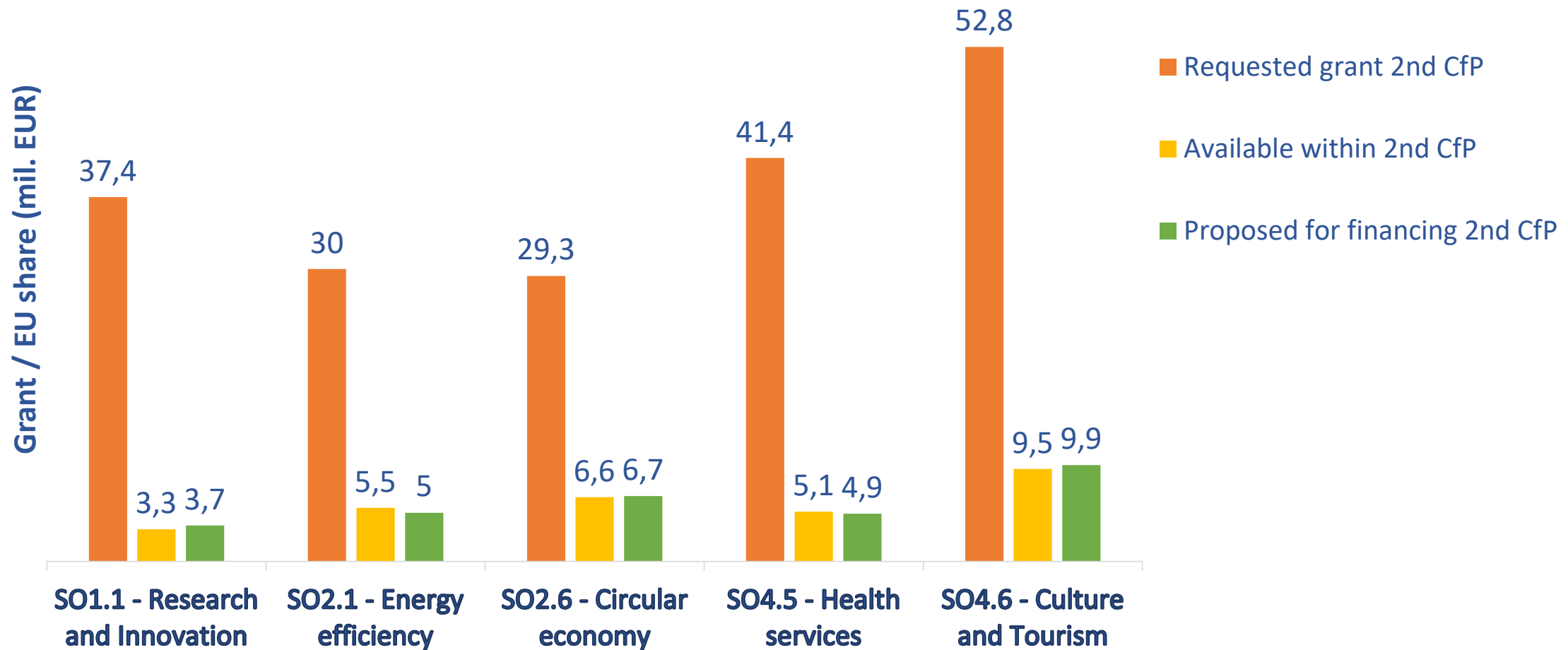

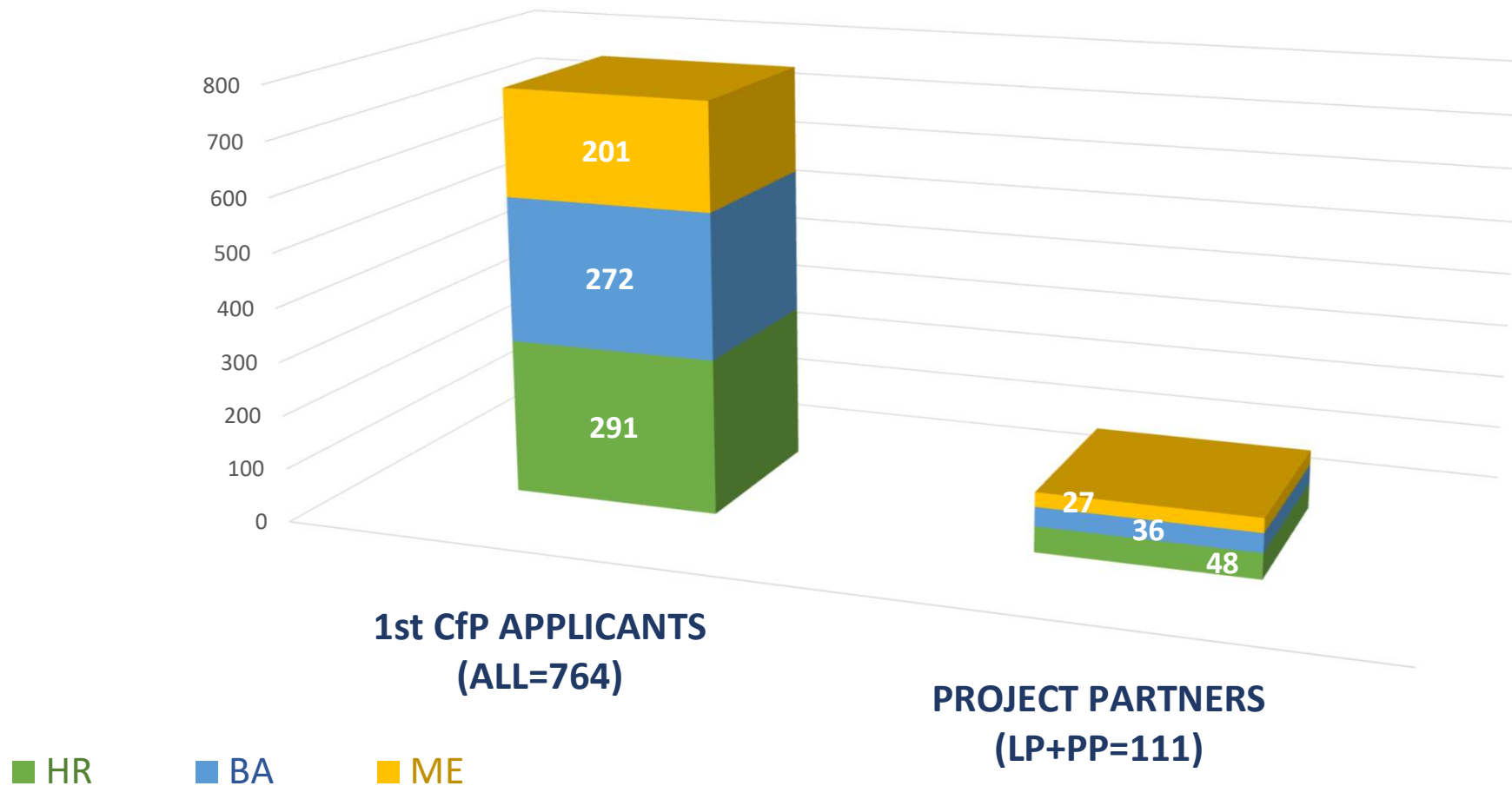

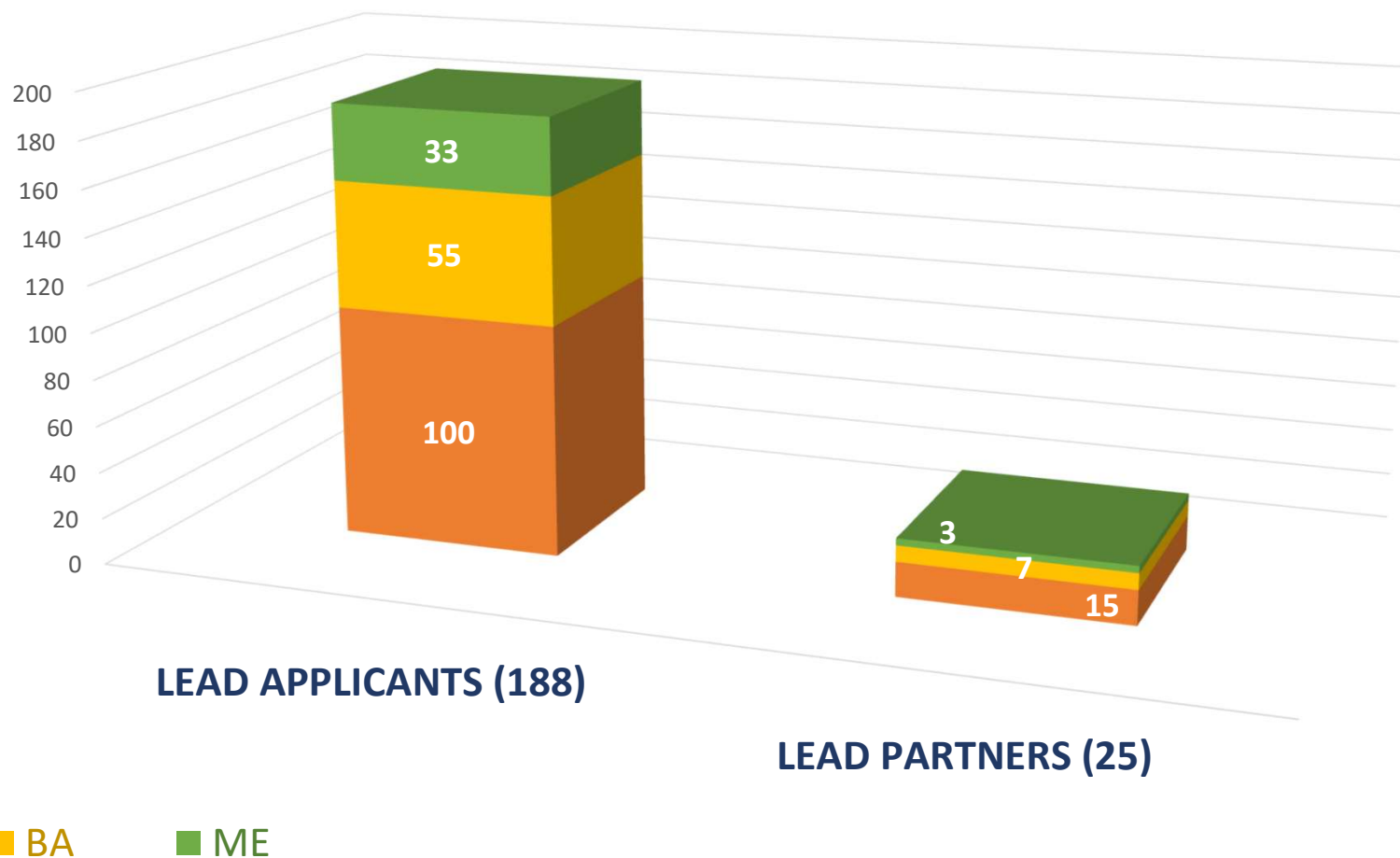
